- To submit nominations, please fill in the attached form. Please note it is important in assisting the awards committee to write a short citation of a maximum of 300 words outlining the reasons why your nominee is deserving of the award.
- Two or more individuals may be jointly nominated for any award if, in the opinion of the nominator, contributed significantly to the effort or project prompting the nomination (for example, a joint research effort).
- Nominations for an individual who has received the same award previously may be considered after a minimum of 5 years has elapsed since the previous award, however only in the event that the current nomination is strictly based upon substantial contributions that differ from those of the prior award.
- Awards may not be awarded in the absence of a suitable nominee
